2. The firms should have a minimum of 3 years of experience in supply/Repairing/Installation of items being procured, and should have proper office in Islamabad, Rawalpindi & Karachi.
3. Sealed tenders are required to reach the undersigned on or before **20th February, 2015** before close of business i.e. 5:00 p.m. along with a cross cheque/Pay Order of **Rs.1,000/-** in favor of "Gun & Country Club Islamabad" (Non-refundable) as bid money.
4. All quotations should be submitted on proper letter head.
5. The rates quoted shall be considered valid for the period of 6 months. The firms will be bound to deliver the goods of the approved quality at Gun & Country Club Islamabad on agreed rates. No delivery charges will be paid.

10. All the taxes levied must also be clearly stated.
11. Payments of the bills and invoices will be subject to the deduction of government taxes.
12. The selected firm should complete the delivery of items as per Gun & Country Club Islamabad schedule.
13. 10% of the contract value will be retained from the payment as retention money & will be released after one month of the satisfactory work.
