1. The firms must have previous experience of Supply of Computer Systems .
2. The firm must be registered with FBR and be on active tax payer list of FBR.
3. The firm must not be blacklisted by any Government department, autonomous body etc. An undertaking on judicial paper must be submitted with the bid.
4. **Only authorized dealers/Sole Importers/Distributors (based in Pakistan) are eligible to apply.** Documentary evidence must be attached.
5. Sealed tenders are required to reach the Club on or before **19<sup>th</sup> March, 2026 (11:00 AM)** along with a cross cheque/Pay Order of **Rs. 5000/-** in favor of “Gun & Country Club Islamabad” (Non-refundable) as bid processing fee. The bids shall be opened on the same day at **11:30 AM**.
6. Bid Security amounting to **Rs. 50,000/-** must be attached with Bid in shape of pay order. The bid security of successful bidder shall be retained till finalization of contract modalities while for the unsuccessful bidders, the same shall be returned immediately after the award letter is issued to the successful bidder.
7. All quotations should be submitted on proper letterhead.
8. The rates quoted shall be considered valid for the period of 2 months/60-days.
9. The rates quoted should be inclusive of all applicable taxes. If not mentioned separately, it shall be deemed that the quoted rates are inclusive of all taxes.
10. The validity of bid is Sixty (60) days from the date of opening of tender.
